Eligibility for Admission

- 1) The candidate seeking admission to the Program should be a Professional/Employee working in Registered Industry / Organization (Central / State) / Private! Public Limited Company/ MSMEs located within 75 km radial distance from the Institute. In proof thereof the candidate shall submit proof of employment from the employer in the form of an employment certificate, the format of which is given in the website.
- 2) The candidate should have been employed in the Registered Industry / Organization (Central / State) / Private! Public Limited Company! MSMEs for a minimum continuous period of ONE Year on Full time / Regular basis. In proof thereof the candidate shall submit proof of continuous employment and conduct from the employer in the format given .
- 3) There shall be no age limit to apply for admission to the program.
- 4) Qualification of the candidate should be the same as that of candidates eligible for Lateral Entry to Second Year (As Specified in Approval Process Handbook published by AICTE from time to time). The candidate should have passed Diploma in ANY branch of Engineering /Technology awarded by a recognized State Board of Technical Education or equivalent with at least 45% of marks (40% marks in the case of candidates belonging to reserved categories) OR B.Sc. Degree from a recognized University as defined by UGC with at least 45% of marks (40% marks in the case of candidates belonging to reserved categories) and passed 10+2 examination with Mathematics as a subject, provided that the candidates belonging to B.Sc. stream shall study the courses Engineering Graphics/Drawing & Engineering Mechanics of the First Year Engineering Program along with the Second Year Courses. These courses can be taken as audit courses. OR D.Voc. Stream in the same or allied sector.

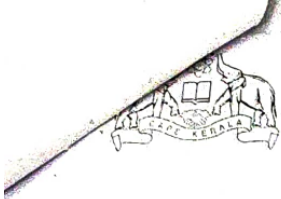

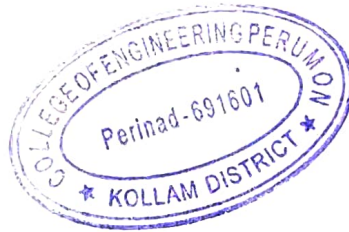
